

AFFILIATE PROGRAM TERMS



By participating in the affiliate program operated by Century LendInvest Limited the Client agrees to abide the affiliate program terms. Failure to strictly adhere to these terms will result in permanent account closure and forfeiture of all commission proceeds accumulated as a result of breach of these rules.

**01**

Affiliate program participants must adhere to laws and regulations of countries where they reside and operate, including any investment advisory legislation. Century Trust is unable to advise on these, participants shall obtain local legal advice independently.

02

Affiliate program participants must not represent themselves as employees or associates of Century LendInvest Ltd. or its affiliate companies.

03

Affiliate program participants may only use permitted marketing materials. If unsure if marketing materials are permitted, participants must contact the affiliate program administrator at affiliate@centurytrust.com for clarification.

04

Affiliate program participants may not use mass marketing methods such as:

- Sending “spam” emails
- Sending mass text or WhatsApp messages
- Utilizing unsolicited direct mail
- Telemarketing or any other kind of unsolicited telephone communication

Affiliate program participants must not redeem incentive vouchers themselves or use them in a way that will in any way benefit them or persons connected to them.

Affiliate Tier Points

Each \$1000 of attracted funds will earn the participant 1 tier point. Once the participant earns 10 tier points, he/she moves to the next Tier, therefore earning higher commission. Tier 3 affiliates earn commission on direct referrals, 2nd and 3rd level referrals and referrals from levels 4-10, while Tier 1 and Tier 2 affiliates are limited to direct, 2nd and 3rd level referrals.

In order to maintain the given affiliate tier, the participant must attract the amount of points required to achieve his/her given tier in every 6 month period. For example, a Tier 3 affiliate must attract at least \$20,000 in every six month period, starting from the date when the participant reached Tier 3.

Vouchers

Century Trust issues investment incentive vouchers to prospective clients who want to explore our system before investing their own funds. Up to 20 voucher codes are made available to participants in the affiliate program every month once the participant earns at least one Tier point. Vouchers can be redeemed at any time and are valued at \$10. Participants are not allowed to redeem vouchers for their own benefit. Voucher codes can be requested by contacting the affiliate program administrator at affiliate@centurytrust.com.

Referral link

Inside your client account console you will find your referral link. Participants can distribute this link to those who may be interested in investing with Century and receive commission once they decide to invest. If the client opened an account without following the referral link that a participant has provided to him/her, the participant should write to affiliate@centurytrust.com with relevant details and participant/client relationship will be established in our system.
