## Currency denomination

Investment pools offered by Century Trust are denominated in U.S. Dollars only. Interest is paid in U.S. Dollars. We do accept Bitcoin deposits, however, these deposits are converted into U.S. Dollars.

## 03

### What is the legal framework?

Century Trust is operated by Century LendInvest Limited as an unregulated collective investment scheme. Century LendInvest Limited is not regulated by the SEC, the FCA or any other government regulatory body. Investments with Century LendInvest Limited are not insured by any kind of deposit insurance scheme.

### What account types are offered?

**Individual investment account:** Open to all individual clients and available in most countries. This account enables you to invest money in any of the pools that accept investments from individual investors. This account also allows you to hold cash proceeds and earn commission on referrals.

**Company investment account:** Open to limited companies, public limited companies, partnerships, family, and investment trusts. This account enables institutional and corporate clients to invest money in any of the pools that accept investments from individual and corporate clients. This account also allows you to hold cash proceeds and earn commission on referrals.

### What are the costs associated with investment?

Interest rates offered by Century Trust are quoted “net” of investment management fees. There are no further fees associated with account opening, transaction processing or account maintenance. We do, however, charge fees for the following:

- Probate valuation
- Probate processing
- Wire funds transfer
- Issue of 1099-MISC forms for US taxpayers

### Who holds my investments?

Century LendInvest Limited acts as the appointed custodian for your investments, including cash and crypto-currency. The proceeds of your investments are held in bank accounts in the name of Century LendInvest Limited and cryptocurrency wallets to which Century LendInvest Limited has exclusive access. Client funds are kept segregated from our funds in accordance with industry practices.

## 07

### Who can invest?

For our cryptocurrency denominated investment pools, we accept investors who are citizens of any country apart from citizens and residents of the United Kingdom. We are unable to accept investments in pools denominated in U.S. Dollars from citizens of North Korea, Sudan (North), Myanmar, East Timor and United Kingdom.

## Investment pool “Dream”

Weekly interest - 3.5%  
Minimum investment amount - \$10  
Denomination - U.S. Dollar  
Retention period - 30 days  
Penalty for early capital withdrawal - 100% of interest paid  
Available to individual accounts only

## Investment pool - “Alpha”

Weekly interest - 4.5%  
Minimum investment amount - \$100  
Denomination - U.S. Dollar  
Retention period - 60 days  
Penalty for early capital withdrawal - 100% of interest paid on  
Available to individual and corporate accounts

## Investment pool - “Alpha Plus”

Weekly interest - 6%  
Minimum investment amount - \$100  
Denomination - U.S. Dollar  
Retention period - 120 Days  
Early capital withdrawal is not allowed  
Available to individual and corporate accounts
